Wanting to enter the Long Format Competition at Rebecca Farms? Or, the CCI 1\* will be your first FEI Competition..... Maybe you just want to improve your Cross Country skills?

Preparing for Long Format competitions are different than a regular Horse Trials. Distances are further and a greater degree of fitness is required for the horse and rider. Preparation during the days leading up to the competition date is different.....

This clinic will cover everything you need to know including fitness, rider support, galloping at speed balanced and safe, how to present properly at the Jog Up, Vet Box, Roads and Tracks, Steeple Chase, Walking the course and measuring with a wheel and minute markers. Equipment required in your tack box and at the finish line. How to plan your day based on your ride times.....just to name some of the topics that will be covered.

We will also hold a short mock run so riders can experience Phase A, B, C, D and know what to expect at the competition.

1\* riders will work on all aspects that pertain to them including practising Galloping fences and then the transitioning for the technical portions of the XC.

As the fitness for the horse is greater for these types of competitions, we will be contacting the clinic registrants and ask them to submit their fitness schedule, ideally in April, so that the instructors can look it over and make any recommendations if change is required.

Clinicians are Rebecca Lee, Samantha Balogh and Dr. Alyssa Butters.

**Rebecca Lee:** well known Alberta Rider/Coach/Trainer now located in Virginia. Go to [www.rebeccaleeeventing.com](http://www.rebeccaleeeventing.com) for more info on Becky.

**Samantha Balogh:** has been working and riding in Europe for the past 5 years and is currently located in Germany. She spent 2015 working for William Fox Pitt and will bring a great deal of knowledge and insight to this clinic that has been gained from working for one of the top riders in the world.

**Dr Alyssa Butters:** Dr. Butters works for Burwash Equine Services. She is the Veterinarian who oversaw the Long Format Divisions at Rebecca Farms, last year. Dr Butters will be discussing how to present your horse properly at a Jog Up; What happens at the Vet Box and Finish Line during competition. Also, what happens when you are sent to the Holding Area, if the Jog up did not go so well.
