MESSAGE FROM THE PRESIDENT

As President of the AHTA I am pleased to present our first Annual Report on behalf of the Board of Directors.

2021 was indeed a challenging year, but I can assure you that the collective strengths of the AHTA board were all constantly at work to advance our Association; and although the AHTA is a sports organization and not a regulating body, we still felt the responsibility to advocate for our sport during the pandemic.

The pandemic highlighted the strength within our community as a whole, and the common bond that unites us all during difficult times, and to focus on what brings hope and joy to so many of our lives – horses.

We fought hard to be able to run our clinics for you, and for competitions to run during the tightest government restrictions. I can personally attest to advocating almost daily with various levels of government throughout the spring - spending countless hours researching, connecting with other equestrian groups and governing bodies, and drafting our own set of guidelines to submit to the government for consideration.

Eventually everyone's efforts paid off and the AHTA was granted exemptions from the AHS to run clinics in June. Once government restrictions were lifted, we were very pleased to host the rest of our planned clinics, as well as support the 4 sanctioned events that ran.

Upon taking the role as President I conducted an initial governance review and found that there were several gaps. In conjunction with my fellow board members, we introduced several new policies as well as improved existing policies including:

- A new Medical Services Policy and Guidelines
- An Updated Event Site Funding Policy
- A New Substance Use Policy and Witness Statement
- A New Complaint and Appeals Procedure
- An updated Rider Representative Policy
- A New Board Member Roles & Responsibilities Policy, which includes the following policies under its umbrella:
 - Director Code of Conduct
 - Conflict of Interest
 - Confidentiality
 - o Document Retention



Safety remains our paramount priority and many of these policies were put in place with that in mind. In addition, 2021 involved several other key safety initiatives including the decision to direct all 2021 event site funding specifically to frangible technology. Each event site was offered a \$2500 grant to be used for the building or retrofitting of frangible fences. The AHTA also

formalized our medical services policy which outlines the recommended standard and minimum standard for medical services providers at an event, and includes an incentive of a \$1000 grant per event which can only be accessed by meeting these standards.

As we begin a new year, the AHTA will continue our work to support the goals of our members. We have listened and learned from all of you and have strived to provide services which meet your needs.

Thank you for your membership, your support, and your contributions to our amazing sport.

SAFETY REPORT

Out of the gate, the board had to develop some safety specific policies to ensure compliance to some of the ongoing concerns that had been brought forward through various situations. We hope these serve our members well and provide guidance if these events do arise:

- AHTA Substance Use Policy and Witness Statement
- AHTA Complaint and Appeals Procedure
- AHTA Medical Service Provider Guidelines for Events
- AHTA Frangible Pin Discussion

The enhancement of the rider representative reporting allowed for the board to review key items that were of importance to the members. Concerns brought forward by members throughout the event were documented for review. This allowed for the board to reflect on those items. Overall we were impressed with the ground jury and event organizers for taking care of issues that were brought forward by members. Rider Representatives also captured jumps that caused refusals or falls so we could start to examine those for trends and feedback to the event organizers.

Throughout the pandemic the ability to maintain and monitor safety statistics was a challenge. Due to only two sanctioned events being held in 2020, we were unable to establish any safety statistics for the 2021 season. We look to enhance those metrics in 2022.

The board was able to collaborate with the Eventing Committee on safety topics such as MIM frangible technology. Through this collaboration, we were able to put forward the MIM frangible pin order from the Alberta Event Organizers with the rest of the Canadian Eventing Associations. This allowed us to ensure event sites got the best pricing on the MIM Pins. The grant program established through the AHTA and the support of the Eventing Safety In Memory of Katharine Morel and Kerry On fund will ensure event organizers are provided funding for the design, build, and construction materials of the frangible jumps. Hopefully with the border opening we can see more opportunity to have course designers and builders assist event organizers in building these jumps.

It was incredible to see the hard work by event organizers that have already designed and built frangible jumps. We are thrilled to see these jumps being used next year!

Thank you to all members, support teams, volunteers, coaches and event organizers for the dedication they have shown for the two years during this unprecedented time. See you all next year!

HIGH PERFORMANCE REPORT

2021 marked the 14th year of the High Performance Program in Alberta and the first year for the addition of a U18 division.

There were 23 riders in the High Performance Program (8 HP and 15 Development) plus 11 U18 for a total of 32 riders under the HP umbrella. Leahona Rowland entered her 4th year as being the program coach/consultant.

Educational sessions included mounted and unmounted sessions. Peter Gray videoed a number of Prelim dressage riders at a schooling show in FL and provided his judges comments. Zoom educational sessions included a representative from BFL Canada discussing Equine Insurance and Dr. Sarah Pedersen covering Equine Fitness and Recovery Management. The zoom sessions were open to anyone interested in attending, at no cost.

Tanja Minder spent time at one of the clinics talking about Equine Ulcers and Becky Staden discussed Social Media Behavior and how it can affect Sponsorship Opportunities. Shandiss McDonald also added to the discussion with comments regarding her work on the EC Eventing Committee and how EC High Performance does look at rider social media accounts and the behavior expected from EC HP riders.

Clinicians who taught the mounted lessons included HP Coach Leahona Rowland; Shandiss MacDonald and Darren Coady. Clinics were held at RoseBush Equestrian in Sturgeon County; Cochrane Ag Grounds; and at Alhambra Stables. If a clinic did not fill or if there were some last minute withdrawals, these open spots were offered to any AHTA members who rode at the level. Filling the spots did prove to be difficult due to the increased competition for a rider's money as there were additional clinics running at alternate sites on the same weekend.

The COVID restrictions that were in place early in the year negatively affected our bottom line and contributed to the financial loss of \$3,392. We had to reschedule various clinics as well as deal with numerous rider cancellations when our junior riders were having to quarantine at the last minute because of exposure in the schools. Also, at the start of the year, only 1 senior rider was allowed in a lesson which added to the negative financial pressure. This loss will be covered out of the High Performance cash reserves. The Cash Reserves include the 2019 Silent Auction funds and money that is in a US Savings account. This account had been set up to pay our American clinicians. Money had been transferred into it when exchange rates had been favorable. The 2021 Silent Auction money of \$2615 is set aside to offset expenses in 2022.

Fees will be increased for 2022. We tried to keep clinic fees as low as possible in 2021 due to the current economic downturn from COVID and did not want to exclude any riders who are running on a tight budget. However, clinic fees will be increasing in the upcoming year as all clinicians have indicated their fees have gone up. We also saw substantial increases in airfare expenses this year so expect the same to carryover to 2022.

The 2021 High Performance program has been reviewed by myself, HP Coach Leahona Rowland, the HP Advisory Committee and the U18 Advisory Committee. The only change will be the

cancellation of the option of a late membership into the program, as we have had very few riders take advantage of this in the past. We are not changing any of the regular membership criteria as it has been a difficult time the last 2 years with very limited competitions and the inability of riders to compete in the US. If a rider qualified to join the HP or U18 program in 2021, they will also qualify to join in 2022.

The 2022 Registration package is in the process of being prepared now. Registration will open on November 15 and will close December 31, 2021.

We are now in the process of booking clinics for 2022. The one clinic that has already been arranged is the return of Matt Brown and Peter Gray. The High Performance riders can ride with Matt and Peter on June 30/July 1 at Alhambra Stables. July 2/3 clinic dates will be open to the regular AHTA members. Matt will be covering the show jump and cross country lessons. Peter will be teaching private dressage lessons.

Throughout 2021, a number of Youth Team Challenge competitions had been held across the US. At the time that this report is being prepared, we have not received any confirmation whether this program will continue in the US or not. With the American border now open, it is our hope that we will be able to have some young riders qualified to compete at one of the Team Challenges in 2022.

CLINIC REPORT

Seven clinics were initially planned for the summer of 2021, including four regular member and three '101 Clinics'. Local clinicians were hired to accommodate ongoing COVID-19 restrictions and concerns at this time last year.

Because of an increase in COVID restrictions in May, our first clinic was postponed to later in June. Both AHTA clinics held this month operated under COVID Exemptions approved by Alberta Health Services.

Our first clinic (June 12-13) was at Prentice Creek Equestrian Centre with Leah Breakey instructing. This clinic was full with 25 riders from all over southern and central Alberta and Invermere, BC. It was so fun to get out and start jumping again and the weather was fantastic. Feedback was very positive and the facility was in great condition.

June 19-20 saw the rescheduled Becky Staden Clinic at Cochrane Ag Society. 18 riders attended (some initially planning to ride in May were unable to attend this new date). Other than one fantastic thunder storm that soaked the afternoon rides on Saturday, the clinic operated smoothly. Our clinician was appropriately dressed and after a short rain/monsoon delay, the last group continued on. Cochrane had recently made upgrades to the water jump including a bank / drop option.

July 3-4 had riders at Minds Eye Ranch (in the blazing heat on the first day!) under the instruction of Sabrina Glaser (owner / operator of Excalibur Equestrian in Langley, BC.). 18 riders attended. The facility was in fantastic shape with fresh water trucked in for the water jump and for bathing hot horses. Sabrina stayed on the grounds in the Bed and Breakfast operated by the hosts. The clinic feedback was very positive and Sabrina has agreed to come back and teach in Alberta again.

Alhambra Stables hosted the fourth annual Ride and Dine Clinic with clinician Jenn Smart (this clinic was full with a long waitlist by 1400 hrs opening day!). Riders had a great lesson on Saturday followed by an amazing meal with several dessert options. Unfortunately, the decision was made early Sunday morning to cancel the lessons that day as the air quality index was extremely high. Smoke and thick haze from several out-of-control fires in BC contributed. Riders enjoyed a perfect breakfast regardless, and Jenn has agreed to be our instructor again next year.


No 101 Clinics were hosted due to the ongoing restrictions and low interest.

Please know that I am open to suggestions and if you have any ideas or something you'd like to see happen in the future, let me know!










EVENT STATISTICS-Total Rides Per Year






EVENT STATISTICS- Rides by Division

Rides by Alberta Venue









YOUNG PROSPECTS PROGRAM EVALUATION

Going into our 2021 season, there were many unknowns, with everyone hopeful that there would be a competition season, but unsure what it would look like or if it would even happen at all. By the time we were into the end of June it was looking like there might be some resemblance of a restricted competition schedule as in 2020, and then very quickly things looked like we would be able to have a "normal" looking summer season. Happily that did happen and everyone one was able to get a few clinics and competitions in.

As the dates for the Alhambra Summer Event came closer we realized that the 2021 Young Prospects Evaluation was likely going to be able to run. So we happily pulled it together, and were able to have the Evaluation lead into the Alhambra Summer Event once again. We were very happy to see another good turnout of young horses, with 3 Two year olds, and 4 Three year olds coming out to show in hand, followed by a nice contingent of Four years olds, 4 in total, 3 Five year olds and 7 New Prospects.

Our panel of Evaluators this year were Lynda Ramsey, Darci Ecker-Popiel and Laura Pauly.

The fact that the Program continues to run at better than breakeven financially, is largely due to the support that it receives from a few great sponsors; The Thomas family has been a wonderful supporter of the program since it's beginnings, as has Moore Equine. This year we were also happy to have some great competitor package swag courtesy of Hashbrowns Homestead Supplies (just the best little feed store in Red Deer!) and Robert Young, founder of "Riding Defined" who has been our cash award sponsor for a few years now. I cannot thank these sponsors enough, especially this year, when we weren't even able to reach out to our sponsors until we were committed to running the evaluation. With their support we are able to make the Evaluation fees very reasonable. There are some wonderful new sponsors in the wings for 2022!

The registrations for the evaluation from year to year are remaining fairly consistent. The numbers we have been getting are enough to fill a day, and we would be hard pressed to fit any more entries into the format that we are currently using. As enjoyable as it is looking at all the lovely youngsters, it really is hard work for our panel of evaluators as they strive to be thorough and take the time to evaluate each individual. We appreciate them for their efforts and hard work.

Thanks again to Ulrika Wikner for allowing the Young Prospects Evaluation to take place leading into the Summer Event. This format has proven to be a good step for many Young Prospects coming into the life of being competition horses.
